SpeakApp - Terms of use

The following terms and conditions govern all use of the SpeakApp mobile applications and services (Applications). The Applications are offered subject to your acceptance without modification of all the terms and conditions contained in this document and all other operating rules and policies (including, but not limited to, the SpeakApp Privacy Policy).

Please read this Agreement carefully before accessing or using the Applications. By accessing or using the Applications, you agree to be bound by the terms and conditions of this agreement. If you do not accept all the terms and conditions of this agreement, you will not be able to access or use the Applications. Acceptance is expressly limited to these terms.

1. Use of our service

SpeakApp is a communication and location sharing application for smartphones. With SpeakApp, you can see your family and friends on a private map, stay in touch 24/7, and protect your loved ones. Premium subscribers also enjoy unlimited access to the creation of Security Zones, locations of their contacts during the last 60 days, and the unlocking of all instant translation options.

You may use the Service only if you are able to enter into a binding contract with SpeakApp, and only in accordance with this Agreement and all applicable local, state, national and international laws, rules and regulations. Anyone under the age of 13 is strictly prohibited from creating an account for the Service. Additionally, anyone under the age of 13 can only accept invitations from parents / legal guardians to join their account. The Service is not available to any User previously removed from the Service by SpeakApp.

2. Your SpeakApp account

If you create a SpeakApp account, you are responsible for maintaining the security of your account, and you are fully responsible for all activities that occur on the account and for any other actions taken in connection with the account. You must immediately notify SpeakApp of any unauthorized use of your account or any other breach of security. - Unlock the Translation options, including the one that allows you to maintain a Chat that simultaneously translates conversations with users who speak a language other than yours.

Offers may vary by location.

b) Billing policies.

If you choose to use the Premium Subscription, you agree to the prices and payment terms, as we may update them from time to time. SpeakApp may add new services for additional fees and charges, or modify fees and charges for existing services, at any time in its sole discretion. Any change in our prices or payment terms will be effective in the billing cycle after you are notified of such change as provided in this Agreement.

c) Prices and payment conditions

The SpeakApp subscription is paid in advance. All subscription and access charges to the Service are paid in advance. SpeakApp reserves the right to offer a free trial period, which will automatically renew to a paid subscription at the end of the trial. SpeakApp is not responsible for any charges or expenses incurred as a result of charges billed by SpeakApp in accordance with the Terms of Service (eg, Overdraft accounts, exceeding credit card limit, etc.) . If any part of this Agreement is held invalid or unenforceable, that part will be construed to reflect the original intent of the parties, and the remaining parts will remain in their entirety for the duration of the term. A waiver by either party of any term or condition of this Agreement or any breach thereof, in any event, will not waive such term or condition or any subsequent breach thereof. You may assign your rights under this Agreement to any party that consents and agrees to be bound by its terms and conditions; SpeakApp may assign its rights under this Agreement without condition. This Agreement shall be binding and secure for the benefit of the parties, their successors and authorized assignees.
